Prior to May 15th and after Sept. 15th Campers MUST be self-contained



Camping Rules and Regulations

1. Duman Lake County Park is utilized by many people for purposes other than camping. Please be considerate of other park patrons during your stay.
2. Campsites in the park are provided for vacation and recreational purposes only. Occupancy of campsites for any other purpose is prohibited.
3. The park provides a waste receptacle for refuse accumulated during your stay. Please place all waste in the dumpster prior to vacating the site.
4. Feeding of all wildlife is prohibited.
5. Operation of electric generators causing unreasonable or excessive noise is prohibited.
6. Boisterous, immoral or indecent conduct will not be tolerated.
7. Driving nails or other hardware into trees and shrubs

Campsites Include— 40 ft R.V. pad, fire ring, picnic table, electric and water. Sewage is also available.

Tents Sites— Available upon request for a fee of \$20per night.

Pets —Pets are permitted in camping and recreation areas provided they are on leash not exceeding six feet in length and attended at all times. Patrons are responsible to clean up after their pets.

Alcohol — Beer is the only alcoholic beverage permitted. Underage drinking is prohibited. Public intoxication is also prohibited.

Visitors and Quiet hours — Visitors are welcome to your campsite between 8:00 a.m.-9:00 p.m. Quiet hours are 9:00 p.m.– 8:00 a.m. Unnecessary disturbances and noises are prohibited during quiet hours. (There will be **NO** generator usage permitted during quite hours)

Fires and Firewood — Fires are permitted in the provided fire rings and grills. Gas propane camp stoves are also permitted. Fire must be attended at all times and extinguished before leaving the campsite. Firewood is not provided. **Not permitted:** Cutting live or standing trees and the operation of chain saws.

Maximum people per site & camping period — Site occupancy is limited to one family unit (persons living under one household) or one non-family unit limited to five people per site. At least one responsible individual 18 years of age or older must be present. The maximum camping period is 14 consecutive nights providing campsites are available. All camping equipment must be removed from the park for at least 48 hours at the end of any 14-night period.

Reservations — Reservations can only be made by calling the County Operations Office at (814) 472-8514 (payment must be made within five (5) days) of making the reservation or the reservation will automatically be cancelled.

Campsite Issuing and Overnight Occupancy — Unreserved campsites are available on a first come first served basis. Campers must register and pay fees to the park security personnel at the park office before setting up camp. If no park employee is available at the time of arrival, read the posted instructions and check the “reserved site list” then proceed to an available site and set up.

Check-In/Check-out Times —Both check-in time and check-out time is 4:00 p.m. Campsites must be vacated by 4:00 p.m. unless the permit is renewed (pending site availability) before 12 noon and is within the 14–night limitation. Overnight campsite occupancy is mandatory during the entire camping period.

Refunds and Cancellations —Advance reservations cancelled at least 30 days prior to check-in are eligible for a full refund. Reservations cancelled within 14 days of check-in will be charged for the first night of the reservation period. Refunds must be requested by calling or writing the County Operations Office.

Motor Vehicles —Only one car in addition to the camping unit is allowed. Additional vehicles must be parked in other public parking areas within the park.

Shower Facilities — Shower facilities for men and women are available. Personal hygiene shower supplies will not be provided.

Water Hydrants — Water hydrants located at the campsites and throughout the park contain potable water and are part of a permitted water system.

Hunting — Hunting and trapping is prohibited. Discharge of firearms, archery equipment, slingshots, projectiles or explosives within the park is also prohibited.
