YEAR END CLOSEOUT Scheduling



It is **<u>imperative</u>** that you schedule your closeout appointment so that we are able to process everyone in a timely manner.

The first possible day to closeout is <u>Monday, January 5th</u> and the last day is <u>Thursday, January 15th</u>, all tax collectors must be closed out by 1/15/15, <u>no exceptions</u>. Appointments are available between 9:00 AM and 3:30 PM, in half hour intervals, unless you feel you need more time. <u>All tax</u> <u>collectors are required to call or email Pam one day prior</u> to your scheduled appointment to verify the ending <u>balance.</u>

DIRECT DEPOSIT OF EXPENSES

If you would like to have your expense reimbursements directly deposited into your personal account Pam will have the paperwork available during closeout, please bring a voided check with you.



SPECIAL NOTICES

Special notices are to be sent to every taxpayer who has not paid their taxes four months after the original notice was sent or when penalty starts. This is based on House Bill 1725 of 2006.



The tax collector may choose to wait until the School taxes have entered penalty to mail the special notices so that one notice is sent for all real estate taxes.

If you have not already done so we advise that notice be sent immediately.

COUNTY/MUNICIPAL TAX BILL PROCESSING

Infocon has notified us that they will no longer be spliting the invoicing for the tax bill processing. Currently, the invoice that you receive is for the Municipalities portion only and the County receives an invoice for all tax collectors for their portion. You will now be responsible for paying the bill and requesting reimbursement from the County and Municipality. The County will make every effort to process the reimbursement within 14 days of receipt of the request, you may submit your request by mail, fax or scanning and emailing the invoice to Emily. Please keep in mind that the full amount relating to the Per Capita Tax is the Municipalities responsibility. Also if your Municipality requests a copy of the dupliciate (the blue binder) they are responsible for the full amount plus 1/2 of the other. If when Emily receives your request for reimbursement she has any changes she will notify you immediately.

FROM THE TAX CLAIM BUREAU

I would like to thank the Tax Collectors Association for inviting me to speak at their annual conference in October. As always, I truly enjoy your company and always gain insight to your problems and concerns.

At the meeting, each collector received a list of properties available for tax sale in their respective district. My goal was to have you review the list to see if any of the properties could be promoted to a tax sale. Maybe you could inform a neighbor of an available property which would benefit or enhance his/her property. Or, you could converse with your municipal supervisors and request a municipal eyesore for Judicial Tax Sale.

To my delight, several collectors called to inform me of trailers on their list which were no longer there. And these trailers have been removed from the Tax Claim's list....thank you very much!!

My concern is the growing number of properties available for sale. This year, 304 properties did not sell at the annual Upset Sale and were added to the list. Tax Claim sold only 142 properties at various tax sales in 2014. In the past, we would be approximately even with the properties sold and the properties added, so you can see the reason for my concern.

For the collectors not present at the conference, I have included their district's list of properties available for sale with their 2014 Unpaid Tax Return information. I would appreciate your review of the list and welcome any comments or suggestions.

As always, do not hesitate to call our office on any matter.

I look forward to seeing you in January 2015 when returning your unpaid taxes and sincerely wish each of you and your families a wonderful and blessed holiday season.

HOUSE BILL 1590

On October 22, 2014, Gov. Corbet signed House Bill 1590 into law. This Bill amends the Local Tax Collection Act that concerns Basic and Continuing Education Programs for Tax Collectors, Criminal Record History, and Appointing a Deputy. If you have not received a copy of the Bill please contact our office and we can provide you with one. <u>As only one section</u> of this Bill takes effect immediately we have decided we will discuss the other changes further during our seminar in May 2015.

The amendment to Section 22, Deputy Tax Collectors takes effect immediately. It reads "At a minimum a Tax Collector shall, with the approval of the Taxing District and the Tax Collector's surety, appoint a deputy tax collector who will collect and settle taxes during any incapacitation of the tax collector. The deputy shall collect and settle taxes for the duration of the tax collector's incapacitation, unless the taxing district determines action under section 4.2 and 4.4 is As used in this subsection, the term necessary. "incapacitation" shall mean temporarily or permanently imparied by reason of physical illness, physical disability, metal illness, mental deficient or other cause to the extent that the person lacks sufficient understanding or capacity to make or communicate reasponsible decisions concerning the collection and settlement of taxes."

Please take the necessary steps to comply with this section of House Bill 1590. Should you have any questions please contact our office.

A FEW REMINDERS...

- If you are utilizing a computerized program for your tax collections don't forget to back-up your program periodically, the best practice would be to back-up after every time you use the program.
- If you deposit your own funds into the account remember it should be done via a check and when your audit is done be sure to notify Emily. If we do not have the amount of your personal funds documented at the end of your term those funds will be considered unknown and will be split between the taxing districts.
- If your checking account earned interest during 2014, remember to pay it to the taxing districts by January 2015.
- All expenses for 2014, such as: postage, envelopes, checks, or deposit slips are to be submitted for reimbursement before December 31st. The tax collectors' expenses are budgeted for each year, and they should be paid for within the year the expense was incurred.
- If you have Assessment changes you have not yet reported please get them in before close-out.
- If you have not yet submitted your warrant for your 2014 qualified assessment changes please do so immediately.
- If you have outstanding checks that are older than 6 months please reissue. If you have previously reissued these check and they still have not cashed it may be time to consider reporting them as unclaimed property to the PA Treasury. Contact Emily for more information.
