# REPORTING ASSESSMENT CHANGES

Assessment changes should be reported on your weekly return as soon as they are received from the Assessment Office. Further, it is important that the control numbers associated with the changes are reported on the weekly return as well. It can be confusing, especially with the tax collection programs, to identify what assessment changes are being applied unless some indication is included. We have had situations where changes were overlooked, at first, because a tax collector had an increase and decrease for the same amount and applied both on the same weekly return. Because the net effect to the balance to collect was zero, we did not catch the changes until later in the year. This is especially helpful to Pam when she is entering the weekly returns during discount. If you have any questions please contact Pam.



# **SPRING INTERIMS**

Spring interim tax bills are for any new properties not picked up before the fall interims and the taxes will reflect the 2018 tax rate. The taxing period for spring interims correlates with the normal taxing periods. Please keep in mind that you may also receive school interim tax bills for the spring as well, so long as your school district is already participating in interims. Spring interims should be treated just as fall interims were. You will add these to your 2019 balance to collect, maintaining one balance to collect throughout the entire year.

The following are some tips to keep in mind when it comes to interims:

- What tax year is it for? The tax year is important as the millage rates can be different
- How many months are being taxed? *Unlike the normal tax year, interims may be for 12 months, but they could also only be for 10 months or 7 months, etc.*
- What are the taxing periods?
  - Spring Interims follow the same tax periods as the normal tax year.
    - Discount: March 1<sup>st</sup> April 30<sup>th</sup>
    - Face: May 1<sup>st</sup> June 30<sup>th</sup>
    - Penalty: starts July 1st
  - o Fall Interims:
    - Discount: July 1<sup>st</sup> August 31<sup>st</sup>
    - Face: September 1<sup>st</sup> October 31<sup>st</sup>
    - Penalty: starts November 1<sup>st</sup>
- What if I receive an assessment change on an interim? If you receive an assessment change, it is important to look at the duplicate because the amount will be dependent on the number of months taxed.

#### **CLOSEOUT SCHEDULING**

The 2018 tax year closeouts will be Wednesday, January 2, 2019 thru Tuesday, January 15, 2019.

As a reminder, please review all the information received from the Tax Claim Bureau. You are required to obtain your Municipality's and School District's signature on the Certification Sheet **before** you come to closeout.

#### SPEAKING OF INTERIMS...

A total of 96 interim tax bills in 24 municipalities were sent out in July. As of November 16<sup>th</sup> only 15 remain uncollected. A total of \$182,200.35 in additional tax revenue was collected for 2018 for the County.

#### **OUALIFIED ASSESSMENT CHANGES**

Are you submitting for reimbursement of your qualified assessment changes?

If you are doing an assessment change then you are doing a qualified assessment change and should be submitting the proper paperwork to be reimbursed. The County pays \$5.00 per qualified assessment change. If you need additional information on qualified assessment changes please contact Emily or check the Controllers portion of the County website under Tax Collectors for forms.

If you have not submitted for reimbursement of your 2018 qualified assessment changes yet, you still have time. Please submit all requests no later than January 31, 2019.
