# NORTHERN CAMBRIA & CHERRY TREE FLOOD CONTROL RESTORATION PROJECTS

The Northern Cambria Flood Protection Project was designed and built with the traditional wide trapezoidal stream bottom on the West Branch Susquehanna River. At the time, this design seemed logical for flood protection—a wide clean channel—but there were unintended consequences. At low or normal flow, sediment deposition formed islands and bars randomly throughout the project area. These islands and bars can reduce flood protection capacity while creating a maintenance problem. The old way of thinking was to simply dredge the stream channel to remove the sediment bars and islands, but within a short period of time they could form again.

The Conservation District obtained a Growing Greener grant and collaborated with the PA Association of Conservation Districts (Somerset Office), and the PA Fish & Boat Commission Stream Habitat Division to design a flood control restoration project to address the issues. The design included utilizing the islands and bars, lowering some and moving others. The plan used modified mud sills, log faced stone deflectors, random boulders, log faced cross vane deflectors, and saw tooth deflectors, along with installing fish habitat devices to create a narrow low flow, meandering channel. A narrow channel, concentrates the stream flow to run faster and deeper, decreasing sediment deposition. It also increases dissolved oxygen levels, potentially improving flood capacity over time.

The project was completed in August of 2018 utilizing Earth Shapers, LLC, as the contractor to move the stone and logs. The total cost of the project was \$52,840.

An additional Growing Greener grant was obtained to handle a very similar situation on another section of the West Branch in the area of Cherry Tree.




#### NORTHERN CAMBRIA AND CHERRY TREE CONTINUED....

The Cherry Tree Phase II project was also made possible by the collaboration with the Conservation District, PACD Somerset Office, the PA Fish & Boat Commission, and Earth Shapers LLC. The stabilization work was completed in August at a cost of \$41,700.

There is now streambank stabilization and fish habitat that will improve the quality of the water as well as sustain aquatic life. Where fishing was once virtually unheard of, anglers gather for their big catch of the day. With the success these types of projects have achieved thus far, it is very possible that future streambank projects will be considered.

#### 2018 LEGISLATIVE BREAKFAST



Legislators, partnering organizations, directors, and other interest parties were invited to the 2018 Legislative Breakfast hosted by the district on October 12th. The breakfast was held at Kosta's restaurant in Ebensburg, fol-

lowed by a tour of various streambank stabilization projects.

Public and private partnering was the main theme of the meeting, with a focus on stream side

coal refuse removal. A presentation featuring numerous pictures of before, during, and after coal refuse removal served as an appropriate backdrop as Mark Stockley, Resource Supervisor/Chesapeake Bay Technician with the district, and Todd Coleman of MineTech Engineering Inc., spoke of the common sense approach being used by partnering organizations to get important streamside projects completed. Permitting can be a major stumbling block when removing coal refuse completely down to the stream. Innovative thinking and a partnership between DEP, MineTech Engineering, Robindale Energy, the Conservation District, and private landowners, has resulted in some very successful stabilization projects. It was shown that what was once a huge black coal pile polluting the waterway, can be successfully removed and restored to lush green vegetation and cleaner water.

Following the presentation, our guests were treated to a tour of three projects to see first hand, the positive results of this partnership approach. The tour began in Nanty Glo, moved to Northern Cambria, and concluded in Hastings. Each stop along the tour was a location where coal refuse had been laying extremely close to a stream and inevitably washing into the water, but has since been reclaimed. The tour proved to be successful as guests left with a new sense of understanding.







#### 2018 AMERICAN LEGION CAMBRIA COUNTY FAIR

As in years past, the district set up a booth at the American Legion Cambria County Fair. The theme this year featured unwanted plants, bugs, and dirt! Passers-by had the opportunity to identify a variety of different nuisance weeds that grow throughout many backyards. Those who entered the fair booth were invited to play a simple game of 'eye-spy', where they were asked to look for Spotted Lantern Fly nymph and adult props, to bring awareness to the ever growing concern regarding the invasive bug. Those who participated in the game were awarded a fly swatter designed to destroy the Spotted Lantern Fly. While looking throughout the booth, people were also able to get a close up look at some of the methods and supplies used to improve township roads through our Dirt & Gravel /Low Volume Road program.

#### 2018 FAMILY DAY



For \$2 a person, families across Cambria county were invited to enjoy a day of education and family fun at Duman Lake County Park hosted by the Conservation District. As in previous years, the day featured different educational stations set up to provide participants with hands on experiences.

H2Oh! On The Go!, a mobile watershed model, was stationed at the park for our families to visit. The display features a variety of water stations that explain the principles and properties of water. One popular station was building a watershed model in the sand, and then viewing the purple light spreading, indicating rain water, to see how water flows throughout the land.

A WALK ON THE WILD SIDE

Interns from the PA Game Commission took our guests for "A Walk On The Wild Side". Children and parents were engaged in an interactive walk through the nature trail looking for signs of native animals that could be found and identified.

Those who were 13 years or older were provided with the opportunity to kayak, following a lesson on how to kayak properly and safely. Canoes were provided for younger children and parents wanting to get out on the water as well.

The day wrapped up with an interactive show of unique creatures, from the Critters & Conservation organization. Some of the animals featured were a Flat Rock Scorpion, European Legless Lizard, and a Lesser Tenrec

The day would not have been complete without snacks and drinks to keep the learners happy and hydrated! Donations were generously provided by Coca Cola, Snyders of Berlin, and a visit from the Cambria County Dairy Ambassadors handing our Dilly Bars donated by the Hollidaysburg Dairy Queen.

## NEW EDUCATION PROGRAMS-AVALIABLE UPON REQUEST

Four new education programs were recently created and implemented by the District. If you are interested in having a program be featured for your classroom/group, please contact Jackie Ritko at 814-472-2120.

#### WILDLIFE INVESTIGATION

Students investigate 14 stations set up along the nature trail in the 1889 Park. They will be asked to figure out the animal habitat based on written clues and evidence at each location in the park.

#### TRASH TEA

Students are shown water quality tests on trash polluted waters. They then collect their own trash and place it in water for approximately a month. The district staff will visit the group and test the quality of the student's water.

#### **POLLUTION SOLUTION**

Students will conduct experiments to demonstrate how non-point source pollution can affect our streams and rivers. Followed by discussion on how to prevent non-point source pollution.

#### SPOTTED SEARCH

Students participate in experiments related to the daily life of the invasive Spotted Lantern Fly. They are shown videos with the effects of the bug, and then are tasked with finding numerous hidden prop bugs throughout the location.

#### 2019 ENVIROTHON CONTEST

Teachers/Coaches: You and your team of students are invited to attend the 2019 Cambria County Envirothon to be held at Adams/Croyle Recreation Authority 1889 Park on **May 7, 2019.** Students currently in grades 9 through 12 are eligible to compete. Each participating school may send up to three teams to the competition, with each team consisting of three to

five members. Please note that the state rules require that we must send a five member team to the state.

Envirothon subjects include Wildlife, Aquatics, Forestry, Soil/Land Use, plus the 2019 Current Issue topic - *Agriculture and the Environment: Knowledge and Technology to Feed the World.* The winning team will be eligible to attend the State Envirothon at the University of Pittsburgh at Johnstown on May 21 and 22, 2019.

#### **SPOTTED LANTERN FLY**

#### SPOTTED LANTERNFLY INVADER




What is a species called when it invades a new neighborhood and steals food and water from species that have always lived there? Invasive! Students from Forest Hills 5<sup>th</sup> grade recently learned about a "Bad Bug" that has invaded counties in the eastern portion of Pennsylvania, and could very well be headed in our direction. That invasive species is the Spotted Lanternfly (SLF). This insect is causing havoc with grape vines, fruit trees, hops and other crops. The students

learned that the SLF host tree is the Tree of Heaven, but it will also live off of Maple trees, Willow, Black Walnut and Sumac. The insect drives it piercing, sucking mouthpart through the bark of the tree to extract the Xylem of trees,

robbing the tree/vines of nutrition and causing death to these plants. This insect goes through several life stages that begin as eggs laid on the outside of trees, building, rocks, and anything that has a smooth surface. The egg mass of 30-50 eggs is covered with a gray mud. The eggs hatch into nymphs in the spring, which travel up the tree to begin their meal on the Xylem. The nymphs are black and go through several growth stages ending in a bright red and black stage. In late summer the nymph molts into the adult fly stage. This beautiful fly is covered with gray wings with black spots and underlying wings that are bright red. The adult fly will



begin laying eggs in September and will not just lay one batch, but several over the next few months, until the temperature goes below 30 degrees at which time the adult fly will die. The eggs however, will overwinter. These insects also excrete a sticky substance called "Honeydew" which is a clear, thick, sticky substance that sticks to surfaces anywhere the bug is present - trees, forest floor, vehicles, decks, sidewalks. This substance can turn into a sooty mold, suffocating other plants and causing safety hazards. The students were encouraged to take the SLF Challenge – to kill any adult Spotted Lanternfly that they come across and to scrape and destroy any egg masses. In order to keep this very prolific, devastating bug from entering our county, we need to educate everyone on what to look for, destroy it, and report it to BadBug@pa.gov.




## Where is Disaster's Edge Environmental Education Center?
