**TAXPAYER INFORMATION**

Lodging Room Rental Tax is imposed at the rate of 5% of the consideration received by each operator of a facility within Cambria County from each transaction of renting a room or rooms. The tax is to be collected by the operator of each facility from each patron who rents a room. Each operator is required to file a tax return and remit tax due on or before the last day of the month subsequent to the month/quarter\*\* in which the tax was levied.

The tax is to be collected by the operator of each facility from each patron who rents a room. Each operator is required to file a tax return and remit tax due on or before the last day of the month subsequent to the month/quarter\*\* in which the tax was levied.
