

Administrative Review/Report of Sexual Abuse / Harassment, Calendar Year 2024


In comparison to the previous year's allegations, 2024 saw a slight decrease in the number of harassment allegations against staff; nevertheless, none of these allegations were substantiated. Of the three allegations of sexual abuse, two were determined to be unfounded and one founded. Based on review of the facility's PREA efforts, there is no indication for corrective action due to problematic areas, lack of proper training, or a need for new or revised facility policies. All facility staff, contractors, and volunteers continue to complete mandatory PREA training upon hiring, and thereafter during annual development training.

In closing, prison administration continues to maintain best efforts to comply with the standards set forth by the Prison Rape Elimination Act, and to best provide a safe atmosphere for the inmates, staff, and volunteers within the facility.
