First Deputy Warden Patterson reported:

- 1. To date, there have been four hundred and seventeen (417) positive Covid-19 cases at the Prison; ninety-six (96) staff, eight (8) PrimeCare employees, and three hundred and sixteen (316) inmates. This reflects an increase of thirteen (13) staff members and eleven (11) inmates since last month's meeting. All screening, testing, cleaning, social distancing, and quarantine practices remain in effect.
- 2. Since the start of 2021, PrimeCare has been providing the Prison with no-cost rapid-testing kits to use for both staff and inmates. Unfortunately, the supply of no-cost test kits is slowly being exhausted. PCR tests have cost \$155.00 each throughout the length of the pandemic, but the influx of free rapid test kits this year decreased the need for, and costs for, PCR tests. The Prison anticipates the supply of the rapid tests to run out by the end of the year. Therefore, testing related costs are expected to increase.
- 3. During the week of October 18, 2021, Deputy Patterson and Captain Rozum attended the Pennsylvania Prison Warden's Association's Fall Training Conference. The focus of the training was "Risk in Unprecedented Times" and included topics in Alcohol, Drug, and Concealment Trends and Identifiers; Seven Rules of Admiral Hyman Rickover; What is Risk Management; and Why Things Go Right-Why Things Go Wrong. During the conference, elections were held for Association positions. Deputy Patterson would like to congratulate Captain George Rozum for being elected as the PPWA Western District Representative. Deputy Patterson previously held this position but chose not to run for re-election due to his pending retirement.
- 4. Due to additional retirements and the loss of a few recently hired cadets, the Facility will be conducting another Cadet Academy beginning on November 29, 2021, and running through December 24, 2021. The Prison anticipates five (5) vacant full-time officer positions and ten (10) per-diem officer positions being filled through this academy. All those hired will

complete one hundred and sixty (160) hours of classroom training and forty (40) hours of on-the-job training prior to being placed into full duty.

- 5. The mandated annual review of the Prison's Emergency Operations Plan by the Prison Administrative Team and EMA Director Art Martynuska was completed in October. This plan was forwarded to the Commissioners for final approval and signatures.
- 6. The Prison's annual Christmas Party will be held Saturday, December 11, 2021, at the Ebensburg Country Club. Cocktails will start at 6:00 p.m. with dinner and D.J. starting at 7:00 p.m. Deputy Warden Patterson invited the entire Board and spouses to attend.
- 7. The bid has tentatively been awarded to MARC-Service, Inc., pending approval at the November 18, 2021, Commissioners' Meeting.
