Motion was seconded by Commissioner Wissinger and passed unanimously.

Motion was made by Commissioner Wissinger to approve the Agreement with Kronos Incorporated for software and equipment support services at the Cambria County Prison in an amount of \$6,247.81.

Motion was seconded by Commissioner Smith and passed unanimously.

Motion was made by Commissioner Smith to approve the Agreement with Ebensburg Insurance Agency to provide insurance broker services, with regard to the general liability package, beginning February 11, 2016, and ending December 31, 2019, at a rate of \$15,000.00 per year. This is a flat rate in lieu of receiving a 7% commission.

Motion was seconded by Commissioner Chernisky but opposed by Commissioner Wissinger. Motion was passed with a 2 to 1 vote.

Commissioner Chernisky stated that proposals were received from Ebensburg Insurance Agency and Arthur J. Gallagher & Co. The Commissioners interviewed both companies and chose Ebensburg Insurance Agency due to the fact that they have over 20 years of experience handling insurance matters for the County. Ebensburg Insurance Agency also came in at a lower rate, the above-stated \$15,000.00 per year, with Arthur J. Gallagher & Co. proposing \$19,500.00 per year.

Commissioner Wissinger mentioned that Arthur J. Gallagher & Co. has done a great job handling the insurance for the County and that they are one of the largest brokers in the country.

Motion was made by Commissioner Smith to approve the Memorandum of Understanding between the Federal Correctional Institution at Loretto and the Cambria County Prison for mutual emergency assistance for a five-year term

Motion was seconded by Commissioner Wissinger and approved unanimously.

Motion was made by Commissioner Wissinger to approve the one year Loan Agreement with the Cambria Somerset Authority in an amount of \$176,923.00 for Cambria County's share of the 2016 Debt Service.
