NOTE: With the above new hires, this will be the first time that the Prison is fully staffed and have adequate per-diems in over 3 years.

Warden Smith reported:

1. Since last month, there have been no additional cases of Covid-19 at the Facility. All Covid-19 protocols remain in effect. With the 2 national emergency declarations dealing with the COVID-19 pandemic ending on May 11, 2023, this will be the last monthly Covid update moving forward.

2. MAJOR MAINTENANCE/FACILITIES UPDATES:

- a. Kronos Software A follow-up meeting was held with Kronos, Human Resources, and 911, on April 14, 2023, to compile and review the data collected to build the software to the Prison's specifications.
- b. Kitchen Hood Vents As mentioned last month, hood vents needed professionally cleaned. On April 30, 2023, about 75% of them were completed, and the remainder are scheduled for May 14, 2023.
- c. Heating System McCarl's completed its bi-annual preventative maintenance on the entire system from April 4, 2023, through April 21, 2023.
- d. Wall Repairs Due to age, there were 2 areas on the exterior Prison walls that mortar joints on the top rows of the block had deteriorated, and the wall needed repaired. Due to these areas being above exterior recreation yards, it created both a security and a safety concern. Repairs were completed on May 4, 2023, and May 5, 2023.
- 3. As the Warden mentioned last month, the Prison began its MAT (Medically Assisted Treatment) Program for incarcerated individuals who are undergoing treatment for an opioid disorder prior to and during incarceration. The Warden has reviewed the Program with Fred Oliveros, Director of the Cambria County Drug & Alcohol Program, and the Facility will be able to receive reimbursement for the MAT medication and personnel costs, (at least for this fiscal year), for this Program through one of Drug & Alcohol's grant funding streams.
- 4. This week is National Corrections Employee Week. The Prison will be showing its appreciation to staff by serving special lunches each day and raffling off donated items to staff. Annual awards will also be presented this week. The Warden thanked Food Service Director, Jeff Callihan, for putting together the menu as well Deputy Rozum and Fiscal Specialist Tammy St. Clair for collecting the donated items.
