Warden Smith reported:

1. MAJOR MAINTENANCE/FACILITIES UPDATES:

- a. Kronos Software A follow-up meeting was held with Kronos, Human Resources, and 911, on June 1, 2023, to continue compiling and reviewing the data collected to build the software to the Facility's specifications. Another meeting is scheduled for June 15, 2023.
- b. Kitchen Hood Vents The remainder of the professional cleaning was completed on May 14, 2023, and the project is complete.
- c. Kitchen Fire Suppression The bi-annual inspection of the kitchen's fire suppression system was completed on June 7, 2023, with no issues found.
- 2. Since receiving the increase that the Warden negotiated with the U.S. Marshals Service for housing inmates, the monthly average revenue has increased by \$130,000.00 per month. Through the first 3 months of the year, the Prison averaged \$139,000.00 per month in revenue. For April and May, the Facility averaged \$269,000.00 per month.
- 3. The Warden recently updated the MOU for housing juveniles. Solicitor Barbin reviewed the revised MOU, and it was sent to all of the counties that previously used Cambria County for housing juveniles. The rate was increased from \$85.00 per day to \$150.00 per day, and the staffing cost increased from \$34.00 per day to \$37.83 per day, for any staffing or transports out of the Facility. As these agreements are returned, they will be forwarded to the Commissioners' Office for approval.
- 4. The Prison received final audit reports for the inmate canteen fund and the inmate resident fund for 2021 and 2022. The audits were conducted by an independent auditor, Zelenkofske Axelrod, LLC, and no deficiencies were found. However, both audits expressed a 'weakness' in the fact that the Prison only has one employee handling all accounting duties. Best practice, as recommended by the auditors, would be to segregate duties so that no one employee has responsibility for both incoming and outgoing funds.
- 5. Last month was National Corrections Employee Week. This year's award recipients were: Supervisor of the Year Captain Kurtis Wolford; Officer of the Year Officer Robert Nagy; and Employee of the Year Chaplain Art Bucceri.
