

OFFICIAL GENERAL ELECTION BALLOT CAMBRIA COUNTY NOVEMBER 5th, 2024



- 1. TO VOTE YOU MUST BLACKEN THE OVAL () TO THE LEFT OF YOUR CHOICE COMPLETELY. An oval () blackened to the left of the name of any candidate indicates a vote for that candidate.
- 2. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval () to the left of the line provided, and write the name in the blank space provided for that purpose.
- 3. Mark ballot only in black or blue ink. Use the same pen for all markings you place on the ballot.
- 4. If you make a mistake DO NOT ERASE OR CROSS OUT. Ask for a new ballot.
