


<div></div> <div><p>1. TO VOTE YOU MUST BLACKEN THE OVAL (●) TO THE LEFT OF YOUR CHOICE COMPLETELY. An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate.</p><p>2. To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval (●) to the left of the line provided, and write the name in the blank space provided for that purpose.</p><p>3. Mark ballot only in black or blue ink. Use the same pen for all markings you place on the ballot.</p><p>4. If you make a mistake DO NOT ERASE OR CROSS OUT. If you are unable to return your voted absentee or mail-in ballot by the deadline, you may only vote a provisional ballot at your polling place on election day, unless you surrender your absentee or mail-in ballot and envelope to the judge of elections to be voided to vote by regular ballot.</div>
