Prison Audits:

- We are currently working with Inspector Patrick Zirpoli to conduct an audit of our Training Department and the facility as a whole. This is a voluntary audit we've requested to bring in an external perspective and help us deliver the best possible version of corrections in Cambria County.
- Since the audit directly benefits inmate safety and welfare, it will be funded through the inmate commissary fund.
- The PREA audit was completed in July. While the official results are pending for up to 45 days, the inspector has verbally confirmed that we passed.

Kitchen Updates:

- Food Service Director Mathis, in partnership with The Nutrition Group, has completely revamped our kitchen operations. The facility is now significantly cleaner, and the quality of food for both staff and inmates has greatly improved.
- Additionally, the cost per tray has been reduced to \$1.54, reflecting both efficiency and fiscal responsibility.

Re-Entry Program (Department of Custody and Community Integration):

- A collaborative team including representatives from the prison, Cambria County Drug & Alcohol, Probation, and Behavioral Services reviewed all pending RFQs and selected Goodwill as the provider for the Re-Entry Specialist position. Interviews for the Re-Entry Coordinator are also scheduled.
- The Department of Custody and Community Integration has been physically set up inside the prison. The space will be painted in the coming days. Aside from the paint, this initiative was completed at no cost, thanks to the excellent work of our maintenance department in repurposing the video conference room.
- Counselor Thomas met with Julie Boring of the Cambria County Day Reporting Center to facilitate the introduction of classes provided by GEO for our inmate population.
- Counselor McCoy organized a comprehensive Services Fair, scheduled for September. She sent nearly 100 invitations to companies and service providers across the county to offer inmates access to valuable post-release support.
- The Favor Support Group for both male and female inmates began on July 2, 2025. The program has launched successfully and is already providing meaningful support.
- Prison administration re-engaged with Narcotics Anonymous, which has not been active at the prison in some time. They have agreed to resume group sessions soon.
- Thirty-two children of incarcerated individuals have received birthday presents through our partnership with Go-Re-Entry and Beverly's Group in Pittsburgh.

Training

- A hiring event was held at the Human Resources Department on August 1, 2025, followed by onboarding at the Central Park Complex on August 4, 2025. If retention is successful, we will be fully staffed for the first time in years.
- We produced the first-ever recruitment video at no cost to the county, with staff volunteering their time. It has been a great success, receiving approximately 5,000 views on our Facebook page.
- A pre-employment tour was held on July 30, 2025, to introduce new cadets to the career path they are beginning.
- We reached out to retired veterans of Cambria County Prison and successfully recruited eight retirees to return as per-diem staff. These experienced professionals will help train our younger staff and provide relief in areas such as inmate transport.
- Training Academy will begin August 18, 2025. Officer Sinclair has organized the first-ever re-entry simulation for our new cadets and we have worked with the DOC, led by Counselor Smick and Captain Perino to completely re-vamp our training department.

Operations (continued):**Staff**

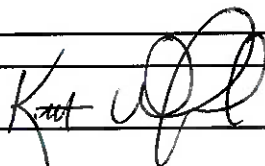
- Swearing in ceremony scheduled for August 21, 2025 at 6:00pm for all of our Supervisors.
- We are currently working with Chief Mark Britton of the Johnstown Police Department to organize a First Responder Ball for emergency personnel across Cambria County.
- Administrative staff attended the CJAB (Criminal Justice Advisory Board) meeting in July, where a significant portion of the discussion focused on advancing our re-entry efforts.
- Members of our administrative team have been participating in leadership training classes at St. Francis University. We've ensured that different individuals attend each session so that all members have the opportunity to benefit from the training.
- The new Correctional Officer uniforms have arrived. These uniforms are significantly more professional in appearance compared to the previous design. All staff will be required to transition to the new uniforms by 2027.
- In an effort to re-establish the chain of command and enhance leadership presence within the facility, we have repurposed the old print shop space to relocate our Lieutenants' offices to the back of the institution. This change will strengthen the connection between Captains and Lieutenants and give Lieutenants a dedicated space to operate effectively. In addition, it will afford our administrative team the ability to better have oversight into the back of the institution.
- Staff recognized for awards of accommodation for exemplary service. This will be discussed at the meeting.
- Using the 12-hour rotations for the Shift Commanders, we have been rotating a Captain position for the 8a - 4p shift in order to focus on working with medical and the transport team in order to streamline our transport schedules and reduce overtime.
- We are bringing back retired Corrections Officers as per-diem staff with the goal of training our new staff in transports, hospital duty, and housing unit operations in order to address our current shortage of experience.

Maintenance Updates:

- The Intertech upgrade is currently on hold as we await parts. Once received, the upgrade will improve our camera system and resolve existing issues.
- We are waiting on K&D to complete the repair of the thaw box in the kitchen. The proposal for the repair has already been approved.

During my first full month of employment, I am finalizing the system Joe and I developed for budgeting, COGS reports, and inventory. I have also created ordering guides with pars to eliminate over ordering of product. I am still working with the Nutrition Group to analyze various vendor pricing, ensuring that we are getting the best prices without compromising the quality of food for staff and the inmate population. I did reduce spending during the month of July compared to June by \$7,470.00 and am currently working with vendors to keep costs low.

Monthly Cost Per Meal

The cost per meal for the month of July was \$1.54 for a total food and paper supply cost of \$54,791.19.

Upcoming Months

I will continue working with Joe Medvan of the Nutrition Group and together we will develop more systems that will help reduce costs per tray while still retaining the quality of food. I have created prep lists for the inmates to follow; this will ensure they are only prepping the quantity that is needed and will help eliminate waste. I will continue monitoring the kitchen staff during the shift to ensure they are following proper procedures and upholding our standards.
