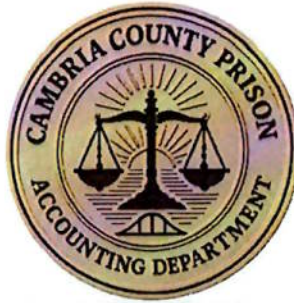

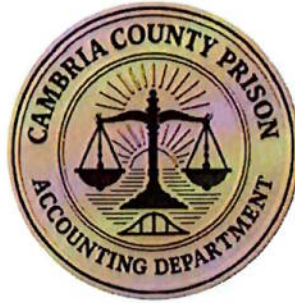

Prison Board Meeting Warden's Report

Board Meeting: December 10, 2025

Prison Audits:

We are still awaiting the updated proposal from Patrick Zirpoli regarding the voluntary audit we requested. This audit is being pursued to obtain a fully independent assessment of our operations and to identify areas where we can strengthen efficiency, consistency, and overall performance across the facility.

Our goal is to bring in an outside perspective that will help us pinpoint what we are doing well and where additional improvements can be made so that the Cambria County Prison continues moving toward becoming the most effective and professionally operated facility it can be.

Kitchen Updates:

Our Food Service Director, in partnership with The Nutrition Group, has successfully maintained our kitchen standards and operational goals. They have developed a detailed and accountable inventory system while continuing to provide improved-quality meals for both staff and the inmate population.

In addition, the updated food service procedures offer valuable hands-on training for inmates, allowing them to learn meal preparation skills that can support future employment opportunities after release. This approach not only enhances daily operations but also contributes to our broader mission of rehabilitation and successful reentry.

Operations:

Major Maintenance / Facility Updates

We are currently conducting a comprehensive audit of all maintenance-related issues throughout the facility. Once this assessment is complete, we will develop a phased plan of action to address each item in a cost-effective and strategic manner.

Our focus is not only on resolving current concerns, but also on implementing a strong preventative maintenance program. This approach will extend the life of the facility, reduce unexpected failures, and ensure that we are operating the prison's mechanical systems as efficiently and reliably as possible for years to come.

The Administrative Team, along with several Officers, met with Jail Tracker on December 3, 2025, to review the potential implementation of a new digital management system within the facility. This system would allow us to transition away from paper documentation and move toward fully digitized records and operational processes. Implementing this technology would significantly enhance efficiency, streamline daily operations, and improve the accuracy and accessibility of critical information throughout the institution.

Staff

On November 15, 2025, the prison participated in the inaugural First Responders Ball. This event not only celebrated the dedication and good work of all our first responders, but also helped reestablish a sense of tradition within both our community and our facility. The Ball fostered meaningful collaboration among agencies and departments across the county, strengthening relationships and reinforcing our shared commitment to public safety. Events like this make our community stronger as a whole.

Our new procedure involving the Lieutenants and Captains has significantly improved oversight throughout the housing units. This increased presence achieves two important goals. First, it ensures that our inmate population is managed in a structured, safe environment that supports rehabilitation by providing consistent expectations and accountability. Second, it allows supervisory staff to better support and guide our newer officers, many of whom are still gaining experience in a challenging profession.

Additionally, we have implemented a policy requiring every member of the administrative team to work a housing unit for a full shift once each quarter. This practice ensures that we remain connected to the core mission of our work—direct engagement with the inmate population—and provides inmates with regular opportunities to voice concerns directly to administration. This hands-on approach strengthens communication, reinforces expectations, and helps maintain a positive, well-managed facility culture.

The annual staff Christmas party has been scheduled. All prison board members are invited to attend this event to celebrate our strong correctional staff and the work they have completed throughout the year.

Community Interaction

I, along with Commissioner Chernisky, attended the Johnstown Family Kitchen Thanksgiving Day meal. At the prison, we believe that meaningful community engagement is essential, and building stronger partnerships throughout the county directly supports our mission of achieving true rehabilitation within a correctional setting.

In addition, members of the Administrative Team visited all three shifts on Thanksgiving Day to show support for our correctional staff and to ensure that facility operations remained smooth and consistent throughout the holiday. Our staff's dedication during these times is greatly appreciated, and it is important that they know their efforts do not go unnoticed.

The prison is participating in the annual Ebensburg Christmas Parade this year. This event provides another opportunity for us to engage with the community and highlight the positive work being done at the facility.

On a personal note, the last time I took part in this parade was when my father served as Warden of the old Cambria County Jail and the institution participated under his leadership. Being involved again carries a special sense of tradition and reminds me of the long history and responsibility we continue to uphold.

Operations (continued):**Inmate Treatment**

On November 7, 2025, members of the Administrative Team and the Department of Custody and Community Integration attended the Re-Entry Seminar at Penn Highlands Community College. This event provided an excellent opportunity to highlight the growing need for our Re-Entry Department and to engage in meaningful discussions about the challenges, responsibilities, and long-term importance of building a successful re-entry program.

Re-Entry quarterly meeting was held on November 13, 2025. During this meeting, the Bridging the Gap program was reviewed, with a focus on strengthening the processes necessary to ensure its long-term success. Since September 15, 2025, the program has received 45 referrals, with 10 participants currently enrolled. The remaining 35 referrals did not meet eligibility criteria.

The goal of Bridging the Gap is to provide individuals being released from custody with stable, temporary housing to support their transition back into the community. By addressing this critical need, we aim to improve each participant's opportunity for long-term success and reduce the likelihood of reoffending.

Members of the Administrative Team met with representatives from DDAP to discuss adding a gambling addiction class for our inmate population. This initiative supports our ongoing commitment to addressing the rehabilitation needs of those in our care and expanding the range of evidence-based programs available within the facility.

We will continue exploring additional voluntary treatment opportunities that align with our mission while ensuring we remain fiscally responsible. Providing targeted, cost-effective programming helps us better prepare individuals for reentry and contributes to long-term community safety. The prison currently offers a wide range of programs to support rehabilitation and reentry. These include DRC, Goodwill Industries, GED instruction, FAVOR, GO Re-Entry, Bridging the Gap, Financial Literacy, YouthBuild, AA, NA, PeerStar, and REACH. Together, these programs provide educational opportunities, behavioral support, community connections, and practical skills that help prepare individuals for successful reintegration upon release.


Training

Counselor Smick continues to oversee our Training Department and has completed a full update of all training documentation, ensuring our materials are current, consistent, and aligned with departmental expectations.

Additionally, on December 3, 2025, a job fair was held in partnership with the Human Resources Department to help fill the vacancies on our roster. The event was highly successful, and we are optimistic that we will return to full staffing levels following the completion of our next academy.

This approach has not only contributed to financial savings but has also provided us with a chance to thoroughly clean the freezers and walk-in coolers.

I have kept working with the inmates to reduce waste by overseeing their cooking, ensuring they stick to the recipes and avoid making excess food. It is remarkable that they consistently create very few leftovers, especially since they are cooking for more than 350 people every time.

. I am extremely proud to say that the kitchen officers have also increased their engagement with the inmates to assist in reducing waste. Through our commitment and steady effort, tray expenses have decreased by 14 cents

The Reentry Specialist, Chantal Lasagna, began employment on October 13, 2025. The first intake into the Cambria County Prison Reentry Program was completed on October 17, 2025. Individuals enrolled into the Reentry Program are provided the following services:

- Weekly contact with the Reentry Specialist
- Creation of a Reentry Plan that will create goals in the following areas:
 - Vital Document Obtainment (ID, Social Security Card, Birth Certificate)
 - Employment
 - Housing
 - Substance Abuse Treatment - including MAT transition
 - Mental Health Treatment - including medication transition
 - GED or High School Equivalency Obtainment
 - Basic Life Needs (Food, Clothing)
 - Transportation Assistance
- Assistance in obtaining Medical Assistance prior to release
- Enrollment in pre-release classes available at Cambria County Prison

Every participant enrolled will leave the prison with a portfolio of their accomplishments earned during incarceration, a plan for release (including scheduled appointments), and a support network to help throughout the transition home. Additionally, they will receive post release services from the Reentry Specialist to continue to work on identified goals.

BRIDGING THE GAP PROGRAM

Cambria County, PA, has various reentry programs for individuals leaving incarceration, focusing on housing, employment, health (mental/physical/substance use), and mentoring, with key providers including FAVOR of the Laurel Highlands for mental health/physical and substance abuse. GOODWILL for employment/ vital documents , GED etc and Breaking the Barriers (housing component). We are aiming to reduce recidivism by connecting people with crucial community support for successful reintegration.

Bridging the Gap's major component is getting reentrants into programs when they get released from prison. Housing is also a component but there are some people that are not eligible for housing through this program.

*Referrals were deemed ineligible at this time due to detainers, not sentenced, charges, not meeting the substance use disorder requirement, they are maxing out their probation sentence or do not have 6 months of probation left on their sentence.

Reentry Coordinator has been getting sentencing orders from the records officer which is helping the Bridging the Gap and Goodwill Reentry Programs. I am also meeting with the inmates on the units once a week regarding questions they may have regarding the Reentry Programs.

Reentry Coordinator goes once a week to FAVOR in Johnstown to see the clients and see if there is anything that they may need.
