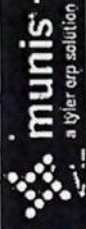

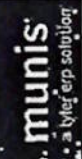

**Operations:****Staff:**

Prison Administration formally commends Officer Shuhayda for his exemplary conduct and professionalism in managing an inmate experiencing a mental health crisis.

Prison Administration commends all staff who reported to work and continued operations during the January snowstorm, as staffing challenges are common during severe weather and our staff stepped up to ensure the facility remained safe and operational.

Prison Administration coordinated with Court Administrator Arrington to initiate security training for all personnel responsible for supervising inmate work crews outside the facility.

Prison Administration has initiated a review process with bid Correctional Officers to evaluate policies and post orders to enhance operational efficiency while incorporating input from frontline staff.

**Major Maintenance / Facility Updates:**

Prison Administration collaborated with local law enforcement, probation, the District Attorney's Office, and local hospitals to develop and implement a new intake pre-screening form to improve medical readiness for individuals being committed to the facility.

Prison Administration is initiating a competitive bidding process for the software service contract to ensure the county receives optimal service at the best possible value.

The lobby was reconfigured to enhance the visitor experience while improving the efficiency of safety and security procedures.

**Training:**

The first training academy for 2026 commenced on January 20, 2026, with Director Smick overseeing a robust training program designed to provide new cadets with comprehensive preparation for duty.

The Commonwealth approved the prison's training academy through 2029 and formally commended Director Smick for his exemplary performance and consistent coordination to ensure compliance with applicable standards.

**Prison Audits:**

Inspector Zirpoli advised of a tentative early March schedule for a voluntary, comprehensive facility audit encompassing all shifts to enhance operational efficiency and the provision of custody and care.

**Kitchen Updates:**

Prison Administration is collaborating with Food Service Director Mathis and the Nutrition Group to establish ServSafe certification opportunities for inmate workers to improve post-release employment outcomes, with qualified candidates referred for potential employment consideration.

**Miscellaneous:**

The federal census came to the institution and successfully completed the 2026 census.

**Operations (continued):****Miscellaneous:**

Interviews for the open Chief Deputy Warden of Operations and Major of Booking and Admissions positions have been completed. All applicants demonstrated qualities aligned with the leadership, professionalism, and commitment we are seeking in these roles. The candidate pool reflects strong interest in advancing within the organization and moving the facility in a positive direction going forward.

We have fully restructured our staff evaluation process to establish position-specific criteria for every role within the prison. Previously, evaluations were more generalized across job assignments. The updated evaluation system provides clear, consistent guidelines that allow supervisors to identify specific areas where improvement is needed, while also recognizing and highlighting areas where staff members are performing at an exemplary level.

**Inmate Treatment:**

Our partnership with Goodwill Industries and the grant supporting the Re-Entry Department continue to grow. Re-Entry Specialist Lasagna is currently managing a full caseload, and Re-Entry Coordinator McCoy is continuing to develop the Bridging the Gap program. This program focuses on individuals nearing release and assists them with securing housing and developing a plan of action for successful reentry into the community.


This coordinated approach is designed to reduce recidivism by addressing reentry needs before release, while also supporting safer communities through structured planning, accountability, and connection to resources.

Prison Administration participated in a Re-Entry Advisory Board meeting on January 21, 2026, to further ongoing work within the Re-Entry Department. The focus of the meeting was on strengthening partnerships, refining programming, and continuing efforts aimed at reducing recidivism and supporting successful reentry into the community.

Prison Administration is currently in the process of soliciting bids for a new barber service for the inmate population. Once all bids are received, they will be reviewed to ensure the selection of the most qualified and appropriate provider for the facility.

**In January, I concentrated on cost per tray. In order to focus on eliminating more expensive items and substituting them with less expensive options without sacrificing food quality, I broke down every item on the inmate menu down to the ounce. That has allowed me to replace items with budget friendly options. We were able to reduce the cost per tray by nine cents! I am very proud of our kitchen team for this accomplishment!**

**I also replenished our emergency supply with fresh product. That did increase our spending cost for January; however, it is reflected in the inventory dollars. I have adjusted the budget for the rest of the year to accommodate the increased cost this past month.**

## January 2026 Training Report February 2026 Outlook

### **TRAINING OPERATIONS REPORT**

January focused on the successful launch of the Cadet Officer Training Academy and significant strides toward institutional self-sufficiency. By securing advanced instructor training and restructuring our mentorship curriculum, we are positioning the facility to reduce reliance on outside vendors to save money while increasing the professional standard of our correctional staff.

#### I. Academy & Curriculum Development

- Cadet Officer Academy: Successfully launched the new class on January 21, 2026.
- Schedule Optimization: Completed a total overhaul of the Academy schedule. Classes have been re-sequenced to improve the learning flow for new corrections cadets, ensuring foundational skills are mastered before moving to the open floor alone.
- Cadet Mentor Program: Finalized the editing and development of the Training Cadet Mentor Program. This is now ready for distribution to Training Officers, providing a structured transition from the classroom to the open floor.
- Curriculum Development Training: Attended and completed a specialized 3-day course at the PA DOC training academy focused on instructional design. This allows myself to instruct all officer training curriculums along with developing my own curriculum for future training purposes.

## II. Compliance & Auditing

- PA DOC Audit Preparation: Conducted a formal online meeting with PA Department of Corrections auditors. We reviewed the annual training curriculum to ensure 100% alignment with state standards. The facility remains on track for full compliance.
- Life Safety Initiatives: Currently in negotiations with the American Heart Association and other local entities to have select staff members as BLS/CPR instructors. This initiative will significantly reduce long-term cost by allowing us to certify staff internally.

## III. Specialized Training & Career Development

- I have secured several high-value training slots to enhance our specialized response capabilities:

- Ongoing monitoring and evaluation of the current Cadet Academy class.

- Currently securing dates for 2026 regional job fairs to proactively address staffing needs.
- Complete the annual refresher training required by the DFP for all staff in regards to the Nu-Tech body scanner.
- Initiate planning with the scheduling shift commander for annual Corrections Officer training that will start at the beginning of March
- Coordinate with the ceremony committee to finalize logistics for the upcoming cadet graduation; ensuring a professional standard for the prison's new officers.
