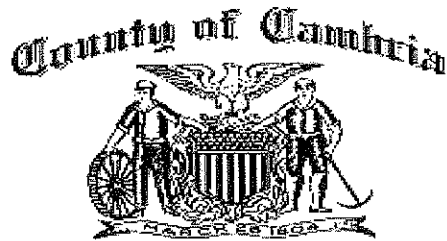

PLEASE NOTE:

THE UPSET TAX SALE SCHEDULED FOR MONDAY, SEPTEMBER 24, 2026 BEGINS AT 10:00AM AND **WILL STOP AT 3:00PM**. IF ALL PROPERTIES HAVE NOT BEEN AUCTIONED AT 3:00PM, THEY WILL BE OFFERED AND AUCTIONED OFF ON OCTOBER 1, 2026 AT 10:00AM AT OUR CONTINUANCE OF THE UPSET SALE.

Reminder: bidders who are slow to bid and wait until just before the auctioneer says "sold" to hold up their number make the entire process longer. If we are to get to all parcels on September 14th, bidding wars need to be kept to a minimum. This is not a game. Many of these are people's homes. It is our goal to get through all the parcels. That can be achieved, but requires bidder cooperation.

ALSO REMEMBER – PAYMENT IN FULL OF YOUR WINNING BID PLUS RECORDING COSTS MUST BE MADE **ON SEPTEMBER 14, 2026** BY CHECK OR MONEY ORDER ONLY.

CAMBRIA COUNTY'S UPSET SALE PROCEDURES

All property must go through an upset sale first. If a taxpayer fails to pay taxes for two years, the Tax Claim Bureau sells the property for the amount of taxes due on the property.

WHEN: Held each September on the first Monday after Labor Day.

NOTICE OF SALE: At least 30 days prior to the sale, property owners are notified by certified mail, restricted delivery (Currently being sent second week of June). Any owner who did not receive the certified notice, will be sent a notice at least 10 days prior to the sale by first class mail, proof of mailing.

At least 30 days prior to the sale, the properties are advertised in the Tribune Democrat, Cambria County Legal Journal and Mainline Newspaper. (Currently being advertised the second week of July) At least 10 days prior to the sale, the properties are posted by the Cambria County Sheriff's Office. (Currently being done around the third week of August)

To remove a property from the sale, the owner or lien creditor may pay the sale year taxes in full or enter into an agreement with the Bureau to pay the taxes in installments as directed by Real Estate Tax Sale Law.

TERMS: Prospective purchasers must complete a bidder application and affidavit during the bidder registration period prior to the sale. Please see our website for forms and deadlines. The sale is auction-style and the property is awarded to the highest bidder. Purchasers must pay the purchase price and the costs consisting of the realty transfer taxes, recording fee, acknowledgment fee, deed preparation fee and demolition fund fee ON THE DAY OF THE SALE by check or money order only.

BUYER BEWARE SALE: This sale DOES NOT divest any liens, mortgages or judgments entered against the property. PROSPECTIVE BIDDERS SHOULD HAVE A TITLE EXAMINATION MADE PRIOR TO THE SALE.

CONTINUANCE SALE: At the September sale, a continuance sale date is scheduled to re-offer any property not sold at the original sale. (Within 30 days of original sale) Following the continuance sale, a petition of the sale results (Rule Returnable) is filed with the courts and is confirmed NISI by the president judge. A certified, restricted delivery notice is sent to all owners informing them their property has been sold and they have 30 days from the date the NISI order is signed to contest the sale of their property by filing an objection or exception with the courts. Within 10 days of the NISI confirmation a general notice of the same is advertised in the Tribune Democrat and Cambria County Legal Journal. Thirty days from the NISI confirmation order, the sale is final when the judge signs the Absolute order excepting any objections filed. The Tax Claim Bureau will record the deed transferring the property to the purchaser and the purchaser will be notified by mail when the deed is ready to be picked up.

You are hereby notified that the CAMBRIA COUNTY TAX CLAIM BUREAU, under and by the authority of the provisions of the Act of 1947, P.L. 1368, known as the "REAL ESTATE TAX SALE LAW" and its amendments, will expose at public sale, at the Cambria County Courthouse, in the Borough of Ebensburg, Pennsylvania on

SEPTEMBER 14, 2026 at 10:00 A.M.

the properties hereinafter described for unpaid taxes.

The purpose of said sale is to provide the collection of the amount of taxes owing on the properties being exposed for sale, together with interest and penalties thereon.

Notice of the return of delinquent taxes against these properties by the various taxing districts and entry of the tax claims thereon has been theretofore given to each delinquent taxable according to law and the period of redemption having expired without such properties having been redeemed, said 2024 claims have become absolute.

Provided however that taxes due and municipal claims due to the Greater Johnstown School District prior to 1985 will not be divested by this sale.

The sale of any property may at the option of the bureau be stayed if the owner thereof or any lien creditor of the owner on or before the actual sale enters into an agreement with bureau to pay the taxes in installments in the manner provided by this act.

Purchasers Note: This is a "BUYER BEWARE" sale, which does NOT divest any liens, judgments or mortgages. Property descriptions are approximates and therefore cannot be assured.

Properties can be located by comparing the map and control number with maps in the Cambria County Assessment Office or Cambria County's GIS System.

The terms of the sale are **PERSONAL OR CERTIFIED CHECK OR MONEY ORDER** at the time the properties are sold. The description of each of the properties to be exposed to public sale is as stated in the tax claims entered including the approximate upset price to be realized at the sale.

IN ADDITION TO THE FULL PURCHASE PRICE, THE BIDDER IS ALSO RESPONSIBLE FOR PAYING THE RECORDING COSTS ON THE DAY OF THE AUCTION. Recording costs include Realty Transfer Tax (2% of the fair market value), recording fee, acknowledgment fee, deed preparation fee, advertising fee, and a demolition fund fee. The costs will be announced with each property.

ALL persons interested in bidding on property at the September 14, 2026 Upset Tax Sale must submit the written Bidder Application in person to the Tax Claim Bureau between Monday, August 17, 2026 and Friday, August 28, 2026. NO REGISTRATIONS WILL BE ACCEPTED AFTER 4:00PM, AUGUST 28, 2026. Registration forms may be found on our website: www.cambriacountypa.gov/tax-claim/ or obtained in our office. *****Pursuant to P.L. 1239, 68 Pa. C.S.A. §2101, et seq., the Pennsylvania Land Bank Act was enacted which in part provides that a land bank may purchase property at a price agreed upon by the applicable taxing bodies. Additionally, the Johnstown Redevelopment Authority, operating as a Land Bank, or the Cambria County Redevelopment Authority, operating as a Land Bank, may be a potential bidder for any or all of the properties to be exposed at the September 14, 2026 Upset Tax Sale.*****

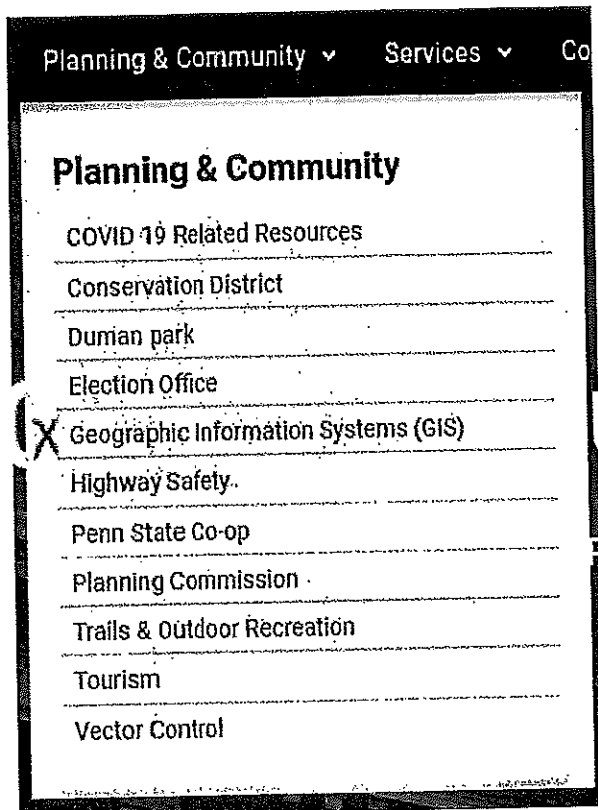
