DECREE OF TEMPORARY GUARDIANSHIP

AND NOW, this _____ day of _____, 20____, upon consideration of the Petition of [Petitioner] to be Appointed Temporary Guardian of _____, Minor Child, and any responses, if any by _____, Parent, and after notice to all interested parties and a hearing, it is hereby DECREED that _____, Petitioner, is hereby appointed the Temporary Guardian of _____, Minor Child.

The Temporary Guardian shall have the authority to act on behalf of the Minor Child as a guardian or co-guardian of the Minor Child.

The Temporary Guardian shall ensure that _____, Parent, has frequent and continuing contact with, and physical access to, the Minor Child, and shall assure the involvement of the Parent, to the greatest extent possible, in the decision making on the behalf of the child.

The entry of this Decrees shall not divest the Parent of parental rights, but shall confer upon the temporary guardian concurrent or shared custody of the child.

The Temporary Guardian may not remove:

- A. the Minor Child, or permit the Minor Child to be removed from the United States either permanently or temporarily without the consent of the custodial parent and the approval of the court;
- B. the Minor Child from this Commonwealth absent a court order, which may only be issued after a hearing at which both parents and the Minor Child shall have the right to be present.
